### Charitable Bequests

Everyone needs a will to provide for the people they care about. A charitable bequest through a will or living trust will create a lasting partnership with our training school and mission. Consider leaving PAALS a specific amount or percentage of your estate in your will or trust.

### Life-Income Gifts Through A Charitable Remainder Trust or Charitable Gift Annuity

### Retirement Plan or IRA Beneficiary Designations
